CTE Expert Review Teams

Purpose

Determine whether schools are implementing CTE programs aligned to the Blueprint vision and monitor progress towards reaching the state's goal of 45% of high school students completing the high school level of a registered apprenticeship or other industry-recognized credential by the 2030-2031 school year

Goals

- identify issues that schools are facing as they expand CTE programming, strengthen programs to meet the new quality criteria, and ensure equity of access for all
- develop recommendations to address challenges faced by schools, districts, and the state in implementing the Blueprint's goals
- **submit reports after each visit** with recommendations to address identified issues
- provide policy and technical assistance support to address challenges faced by individual schools as well as across schools, in coordination with MSDE and the AIB

Why a Pilot Year?

- ☐ Did not receive funding in FY24 to support the full ERT launch
- Collect baseline data to better understand the current state of Maryland's CTE System and develop an approach to school selection
- Align ERT to the CTE Committee's overall state CTE system framework and CTE pathway quality criteria
- ☐ Develop visit tools and protocols, including training for ERT members
- Get input from CTE leaders on ERT program design
- Coordinate with MSDE on ERT planning and sharing of collected information


